The Mississippi Valley Freight Coalition was renamed the Mid-America Freight Coalition in 2010.

Progress this Quarter (includes meetings, work plan status, contract status, significant progress, etc.):

A Technical Committee conference call/webinar took place on September 24, 2012. Agenda items included Annual Meeting information, which will be held April 12-14, 2013 in Louisville, KY. The theme of the conference will be: Building Paths Prosperity – The Role of Regional Corridors. A host/conference committee is working with the MAFC Director on speaker and tours selection and coordination. A venue has been selected and the annual meeting will be held with the Institute for Trade and Transportation Studies (ITTS) states. Other agenda items included new MAP-21 freight legislation, and the discussion of national and regional corridors.

MAFC Director gave presentations at MAASTO SCOHT, MAASTO executive Board, National Association of Regional Councils, Ohio Conference on Freight, ST. Louis Ports Working Group, Mid-Continent 2012 and UW-Madison's TMP class.

Circumstance affecting project or budget. (Please describe any challenges encountered or anticipated that might affect the completion of the project within the time, scope and fiscal constraints set forth in the agreement, along with recommended solutions to those problems).
This contract is currently over budget. At the MAFC Annual Meeting in April 2012, an additional \$10,000 was approved by technical committee members to cover meeting costs. A contract amendment was postponed until the MAASTO meeting in July 2012. The outcome of the MAASTO meeting approved renewing the pooled fund for another three years to 2015. An amendment will be submitted shortly in the amount of \$60,000. This amount will cover the 2012 meeting and the remaining will cover the 2012 meeting. The project's end date will also be extended.
