Project Description:

This program is a cooperative effort of participating state departments of transportation (DOTs) and other (traditional and non-traditional) organizations with a vested interest in traffic safety. This long-term partnership will support an evolving and integrated project portfolio developed and revised each year by the partners and will complement other related research activities. Together, these projects will accelerate the development and delivery of tools and services to transform the national, state, and community level traffic safety culture. The goal of this transformation is to support the Toward Zero Deaths (TZD) vision with sustainable traffic safety solutions.

In this context, the Montana Department of Transportation (MDT) is partnering with the Center for Health and Safety Culture (CHSC) at Montana State University to (1) conduct research to solve specific culture-based traffic safety problems, (2) create training and education materials to enhance workforce understanding and application of traffic safety culture methods, and (3) provide technology transfer of best practices in traffic safety culture methods to all stakeholders. Together, these efforts will support the transformation of traffic safety culture within the families, communities, and organizations of participating states.

This project is in phase 2; the first phase was TPF-5(309) Partnership for the Transformation of Traffic Safety Culture. The current phase will end September 30, 2024, and a Phase 3 solicitation (1621) is open for commitments.

Contract Status

Traffic Safety Culture - Phase 2 Management Support (8882-444-17, 18, 21, 24, & 25)

During this quarter, the CHSC staff provided support and helped facilitate the February quarterly meeting. CHSC sent out the WebEx invites, worked with MDT on agenda development, recorded the meeting, and took meeting notes. Meeting notes for the quarterly meeting were sent to MDT for distribution and posting to the TPF website. CHSC developed the quarterly report for January through March for MDT and the board's review, which has been posted to

the TPF website. The Center staff provided feedback on the Phase 3 solicitation and began preparing promotional materials for Phase 3. MDT and CHSC set a date for a Phase 3 promotional webinar, scheduled webinar, and promoted the webinar through various distribution methods.

Resources and Tools to Reduce Multi-Risk Driving Behaviors (8882-444-20)

During this quarter, the CHSC team completed data analysis of the random control trial, drafted Tasks 3 and 4 report, and developed a resource for practitioners. The draft final report and resources were submitted to MDT for review on June 28th, 2024.

Resources and Tools to Improve Pedestrian Safety (8882-444-22)

During this quarter, the CHSC team worked on Task 3 to develop a toolkit of tools and resources based on what was learned in Task 1 and Task 2 of this project. The CHSC team submitted the draft Task 3 report and toolkit,

Understanding Aggressive Driving and Ways to Reduce It – Phase 2 (8882-444-26)

The Center for Health and Safety Culture (CHSC) was chosen by the board to expand the research completed in Phase 1 by developing and testing one or more strategies to engage bystanders to discourage aggressive driving. CHSC will also develop and test media messaging to reduce aggressive driving behavior. The contract authorizes CHSC to conduct research from May 2024 to March 2026. This is a cost reimbursement contract with a total budget of \$247,573.00. The following is a list of tasks the Center will perform under this contract:

- Task 0: Project Management
- Task 1: Develop Strategies to Support Bystanders in Intervening to Reduce Aggressive Driving Behavior
- Task 2: Test Bystander Engagement Strategies
- Task 3: Develop and Test Media Messages
- Task 4: Provide Recommendations and Resources and Complete Final Report

During this quarter, the CHSC team started this project in late May. The team met to review the project plan and began planning for bystander interviews which is a part of Task 1.

• The CHSC team will continue to work on Task 1 and plans to complete interviews by the end of the quarter. The team will also start working on Task 3 to Develop and Test Media Messages.

Significant Results:

• The CHSC team shared results of the randomized control trial for multiple risky driving behaviors in the final report. While the overall statistical tests on the outcomes of interest were non-significant due to small sample size, participants were able to utilize strategies to address risky driving behaviors. Further, utilization of strategies was maintained through follow-up three months later and participants provided reflections that demonstrated increased emotion regulation and awareness while driving. Together, these results provide promising evidence for engaging young adult drivers in efforts to address multiple risky driving behaviors through emotion regulation in general and utilization of specific strategies for particular behaviors.
