WORK COMPLETED:

TAC Meetings

- Continued planning for the net face-to-face meeting of the Clear Roads Technical Advisory Committee in St. Paul, Minnesota, which was rescheduled for October 25-27, 2011. Planning included communication with TAC members, meeting logistics and agenda development.
