PROJECT TITLE: 2011-2012 Clear Roads Administration and Information Services

**OBJECTIVES**: Clear Roads is a pooled fund research project aimed at rigorous testing of winter maintenance materials, equipment and methods for use by highway maintenance crews. #### **WORK COMPLETED:**

#### **TAC Meetings**

- ➤ Coordinated and attended a face-to-face meeting of the Clear Roads Technical Advisory Committee on October 25-27 in St. Paul, Minnesota. This included communication with TAC members, meeting and travel logistics, agenda development and materials preparation.
- Continued planning for a face-to-face meeting of the Clear Roads Technical Advisory Committee on March 27-29, 2012 in Salt Lake City, Utah. Planning includes all preparations for the meeting such as communication with TAC members, meeting logistics, agenda and meeting materials.
- ➤ Began planning a meeting to advance the implementation of specifications that will enable "plug & play" technology for winter maintenance equipment that will take place on March 26, 2012.

# Research Support

New projects

- ➤ Began soliciting research ideas for 2012 research project selection.
- > Supported MnDOT's contracting process and TAC member involvement in it for 4 research projects selected by the TAC for funding in 2011:
  - o Cost-benefit Analysis Toolkit Phase 2
  - o Determining the Toxicity of Deicing Materials
  - o Environmental Factors Causing Fatigue in Snowplow Operators
  - o Development of a Totally Automated Spreading System Phase 1
- > Coordinated with MnDOT to repost the RFP for the project on Snow Removal at Extreme Temperatures.

## Research in progress

- > Development of a Training Video for Deicer Testing: Coordinated with the project subcommittee and principle investigator for the final report and deliverables.
- > Continued to coordinate with investigators and the Clear Roads subcommittees on the True Costs of Snow and Ice Control and Weather Mapping projects. Distributed interim deliverables.
- > Supported the subcommittee working on the implementation of the "plug and play" specifications for mobile data platforms.
