#### **Project Description:**

This pooled fund will help direct and compliment the use of the MnROAD test track for local, regional and national research, tech transfer and implementation needs. Road owner agencies will provide input and participate in the decision making needed for future MnROAD construction and research scheduled in 2017. MnDOT will provide \$2.5 million in construction funding to aid in the development of the next round of test sections at MnROAD to support common goals. Industry and academia will also play an important role to provide critical input on long-term future trends in research and barriers to implementation, including working with their customers and members who play a direct role in implementation.

#### Progress this Quarter (includes meetings, work plan status, contract status, significant progress, etc.):

To date six state agencies and over fifteen industries and academic institutions have become NRRA members to share their expertise and are learning about new tools and methods to improve and expand upon transportation systems nationally. NRRA members/Teams have started to meet and form research needs for both long term and tech transfer/short term research. The NRRA website is being developed for the teams to use.

#### Anticipated work next quarter:

The following is expected to be completed for the rest of 2016.

- Focus on the Long Term Research Construction planned for 2017 and the test sections need. This effort will be funded by 2.5 million of MnDOT funding for NRRA members to use.
- Long Term Research Contracts will be developed to use both state and the test sections being developed at MnROAD.
- Technology Transfer Topics will be developed and prioritized
- NRRA approved MnDOT to use 5% for administration budget.
- Website will be updated
- NRRA Team Meetings will take place each month and as needed to accomplish its tasks.
- Executive Committee will meet once this quarter.
- Working to expand the NRRA membership to agencies and associates.

#### Significant Results:

Currently NRRA is just starting and the teams are developed and starting to work on research needs. More information on these efforts including the long term research and technology transfer topics can be found under each of the <u>team</u> <u>member's webpage</u>.
