### **Project Description:**

The Institute for Transportation will provide facility coordination and financial assistance for this Pooled Fund Bridge Project, "Building Information Modeling (BIM) for Bridges and Structures for the Iowa Department of Transportation (Iowa DOT), and this project is being led by Ahmad Abu-Hawash from the Iowa DOT. These efforts will entail providing support for two possible meetings.

A project kickoff meeting was held on February 27 - 28, 2018 in San Antonio, Texas in conjunction with AASHTO COBS T-19 Mid-year meeting on March 1. The industry collaboration meeting on February 27 was attended by about seventy individuals representing various industry organizations, contractors, consultants, software vendors, academia, FHWA, and state DOTs. With the input received from the industry collaboration meeting, the pooled fund project TAC met on the following day (February 28) and drafted a request for proposal for the purpose of soliciting professional services from firms specialized in BIM.
