### Project Description:

This pooled fund effort is established to develop a second tier experiment based upon the existing SPS-2 experiment. The objective is to define the proper intervention timing and strategy selections enabling more effective infrastructure management and pavement life extension. In addition, this effort should develop tools for determining strategy selection and pavement life extension for incorporation into pavement and maintenance management systems, support a series of SPS-2 Tech Days, and complete several analyses related to SPS-2 Tech Day input.

- 2. Completed analyses associated with Task 9 and began revising the report.
- 3. Finalized Supplement #5 (developed at WSDOT's request) that included: refining deterioration rates for actual performance and PaveME predicted performance; utilizing existing performance data to assess multiple parameters (e.g., impact of shoulder type on pavement performance); investigating availability of data from non-LTPP sources; leveraging data from two ongoing LTPP research reports involving SPS-2 projects; assessing and updating previous SPS-2 analyses, and; supporting pooled fund communications.

#### Anticipated work next quarter:

- Continue exploring a Georgia Tech Day.
- Finalize revised report associated with Task 9 activities.
- Initiate analyses associated with Task 10 including working to schedule a TAC Meeting.

**Significant Results:** The SPS-2 Tech Days continue to be extremely well received and have generated a lot of interest among the new generation of agency, industry, and academia staff. Articles associated with the Tech Days have either been published or are in the publication process.
