# TPF-5(312) Western Maintenance Partnership Final Summary Report – October 2020 By: Daniel Page, UDOT Director of Maintenance & Facility Management

### **Background**

In the 1980's the Rocky Mountain Maintenance Tour established a highly effective forum for the exchange of information, techniques, policies and strategies for the maintenance of the Highway System. Since that time the role of Maintenance as a critical element in the overall management of the State Highway infrastructure has increased. Most Maintenance managers have been completely replaced since the ending of the Rocky Mountain Maintenance Tour. The primary focus has also shifted from new construction and major rehabilitation to more attention to infrastructure preservation and asset management via cost effective maintenance. Reactive maintenance alone is not adequate to overcome the challenges of rapid deterioration of roads, considering aging of the infrastructure and growing economic constraints.

Transportation Pooled Fund Study No. TPF-5(312), the Western Maintenance Partnership (WMP), has run from 2014 to 2019 and will be closed. The WMP pooled fund is continuing with study number TPF-5(394). The pooled fund previously ran from 2006 to 2014 as TPF-5(145). It has been a worthwhile project for the WASHTO Committee on Maintenance in which the participating agencies pooled their efforts to provide a focused look at Maintenance, and partnered with WASHTO states to share experiences, innovations, expertise and solutions to the complex management of highway assets. Maintenance issues addressed include policies, practices, specifications, field investigations, applied research, materials, and training. Key elements of the annual meetings have included roundtables and sharing of field experience via hands-on demonstration of features.

#### **Objectives**

The purpose of the current WMP is to provide a partnering forum for promoting effective maintenance strategies through the following objectives:

- Provide funds for a multi-day annual workshop for discussion and exchange of information and knowledge about each state's maintenance program.
- Provide a means to define, support and share technology of mutual interest.
- Provide funds for formal training presentations during the annual workshop.
- Provide funds for management support of WMP.
- Provide funds for special studies, investigations, research and training.

As the lead agency for this pooled fund, UDOT created a checking account to assist the agencies that are hosting the annual conference to access and deposit funds as needed to help in acquiring the accommodations, catering, and other services as needed. Every year a deposit was made to this checking account that comes directly from the pooled fund. The location of the annual conference and the expected number of attendees determined the amount to be deposited into the checking account.

## **Accomplishments**

Many ideas have been shared and implemented by a number of states as a result of the annual meetings. This program has helped build a working relationship in the WASHTO states that promotes sharing of ideas and providing help with changing problems. Proceedings of the annual meetings and scan tours were prepared and made available to the participants. #### The Plan Going Forward

In working recently with FHWA and this pooled fund, it has been determined that this TPF-5(312) phase of the pooled fund project will need to be closed. A new pooled fund has been set up under TPF-5(394), and UDOT will again take the lead in administering this process. It is anticipated that the new pooled fund will operate in a similar manner in supporting the WASHTO Committee on Maintenance.
