
The Technical Advisory Committee is finally composed of 31 members, 10 from Europe, 10 from the USA and 11 from non USA or European countries.

#### 4. Received Abstracts


114 abstracts were received, and 92 of them have been preselected for possible papers for the conference. Note we assumed that 20% of the papers will not be written and will not be available for the conference bringing the total number to ~74 papers (92\*80%). An important margin still remains, since the number of technical presentations is 54.



114 Abstacts Presented

Abstracts have been classified into topics to help the organizers group them together in the individual sessions. Papers will be equally sent to all reviewers, independent of the topic. The reviewers will be responsible to comment if they are not able to review paper due to technical content or if they have any conflict of interest with the subject.





Papers for Technical Sessions: 92

The number of papers to be reviewed by each TAC member would be quite large; assuming four reviews per paper (ask for four but at a minimum get three). If only the 31 TAC members were used to review the 74 papers each would review over 9.5 papers each as show below. This may be too much to ask each of them, a better number might be a maximum of 5 papers each. We agreed having other people volunteered for the review process; e.g. members of AFD40 and AFD80 (Strength and Deformation Committee) to reduce the amount of reviews by each person.

The final goal is having a balanced programme with quality papers addressing the appropriate topics. Late papers can be also rejected when the corresponding topic is complete. It was agreed that we should wait to see the actual number of papers. It was also agreed that we should be very demanding in the review process to insure quality over quanity. Finally, it was stated that in any case, if we have more papers than actual time, we could have a poster session for a specific topic that might lend itself well to this form of presentation.

#### Travel Funding

Travel expenses (plane, hotel, conference fees, related travel expenses) will be paid for keynote and the main speakers listed in sections 5 and 7 from the conference (handled by CEDEX). The conference fees will also be paid for the chair and co-chairs of this conference (3 people), but the hotel and travel expenses will come from other funding sources.

The International Conference Pooled Fund Study is an additional source of funding to assist participating states to attend the conference. Minnesota DOT is leading this pooled fund and will in contact with the states to update them on the remaining funds and to request the states intentions for their participation in the Madrid Conference. This pooled fund will continue to support the American Co-Chair's (1 person) travel related to both the development of this conference and attendance in the October conference.
