There now 21 participating State Highway Agencies wit the addition of Louisiana.

A Technical Advisory Committee (TAC) meeting was conducted October 30 & 31st 2008 at the end of the RPUG annual meeting in Austin, TX. The participating agencies were updated on the study progress. There were 16 participants in the session that included attendance by our newest partner, LA DOTD. An update was provided by UMTRI on the benchmark testing contract and by Transtec on the latest update of ProVAL to version 3.0. The action items included checking with other DOT's regarding the establishment of regional profiler certification centers, develop an automated faulting activity proposal for FHWA FALCON process and send a copy of the automated faulting Statement of Work to the entire TAC.

The group voted to extend the pooled fund study for two more years, seek additional participating agencies and seek additional funds. A notice will be sent out through the pooled fund study website once the extension documents have been approved.

- 4. Certification / Validation Sites On Hold for completion of Priority One.
- 5. Evaluating Upper Limits of Single Accelerometer and Single Height Sensor Contractor is on board.
- 6. Emerging Technology That Enhances Profile Measurement Ongoing

Priority One - Reference Device(s):

Benchmark testing and evaluation of potential reference devices has now been scheduled for the week of October 19th beginning at MnROAD for five sections and a longitudinal tined concrete section near Junction City, WI on an unopened section US 10 near the junction of WI 34.

FHWA has issued four awards under the Broad Agency Announcement process that was used to solicit interest in developing a potential profile reference device. The awards were to:

- 1. APR Consultants
- 2. International Cybernetics Corporation ICC
- 3. Surface Systems International, LLC -SSI
- 4. Virginia Technical Institute (FHWA LTTP Funds)

Priority Five - Evaluating Upper Limits of Single Accelerometer and Single Height Sensor: The project has begun with Dr.'s Nicolas Gagarine and James Mekemson of Starodub, Inc. providing the research and report. The phase I report has been provided to FHWA. The second phase will quantify the aspects identified in the first phase report.

Funding - There is currently \$1,361,800.00 of obligated funds from the participating SHA's in the pooled fund study account. A total of \$1.43 Million has been committed to the project over the four year time frame from the participating SHA's. When combined with FHWA funding, a total of \$2,558,000 has been committed to this pooled fund study.

Participating Agencies: California, Colorado, Connecticut, Florida, Georgia, Illinois, Kansas, Kentucky, Louisiana, Maryland, Mississippi, New Jersey, New York, North Carolina, North Dakota, Ohio, Oklahoma, Pennsylvania, South Dakota, Texas and Wisconsin. Also assisting FHWA Federal Lands, FHWA LTPP, and FHWA Office of Pavement Technology (HIPT).
