Task 1, Survey stakeholders, was completed. The researchers had a meeting with technical committee, T-10, in Chicago on April 28, 2013 during PCI Committee Days, to continue to review responses to the survey questions and create general rules for the development of the revised specifications. The survey responses are now being used as input to the following tasks.
Work continues on Task 2, <i>Critically review all interim changes for technical and philosophical consistency</i> . All of the interim changes are now in hand and, the researchers are beginning to cull the significant changes from those which had no effect on the current Section 5.
Work began on Task 3, <i>Develop annotated revised table of contents</i> , with work on straw man outlines fully incorporating the terminology and philosophy of "bending" and "disturbed" regions "upfront" in the section.
Preliminary work began on Task 4, the interim report, by beginning to collect the results of earlier tasks.
